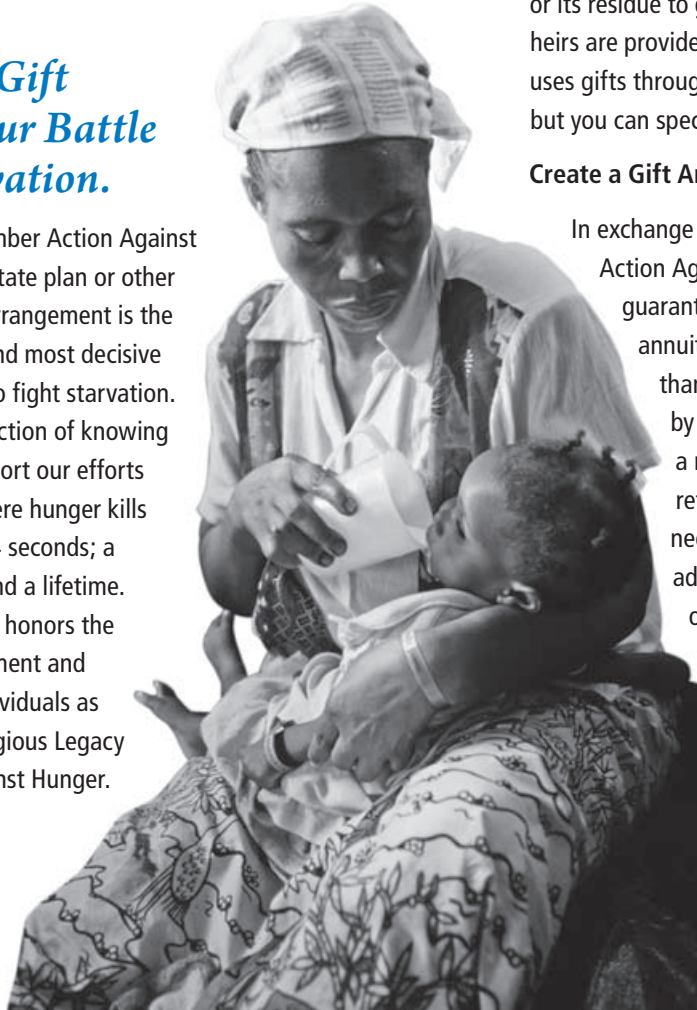

Action Against Hunger honors the extraordinary commitment and generosity of such individuals as members of the prestigious Legacy Society of Action Against Hunger.



How?

It's easy. Consider these simple forms of leaving a legacy of support for the work of Action Against Hunger:

Make a bequest to Action Against Hunger through your will.

A bequest to Action Against Hunger reduces your estate taxes while helping sustain our fight to overcome world hunger. Your bequest can leave a specific dollar amount, property, or you can designate a percentage of the estate or its residue to go to Action Against Hunger after your heirs are provided for. Action Against Hunger generally uses gifts through bequests where needs are greatest, but you can specify a specific purpose or program.

Create a Gift Annuity or Charitable Remainder Trust.

In exchange for a gift annuity of remainder trust, Action Against Hunger promises to make fixed, guaranteed payments for life to one or two annuitants. You can designate someone other than the donor(s) as recipient(s). Funded by cash or securities, both annuities and a remainder trust can provide income for retirement, educational expenses, or other needs. In addition to annual payments, advantages include reduction of taxes owed, and avoidance of capital gains taxes on appreciated securities. We'll work with your financial planners and attorneys to create an annuity or remainder trust that meets your specific needs and wishes.
