PAKISTAN:
AAH-USA RUNS NUMEROUS PROGRAMS AND RESEARCH PROJECTS IN PAKISTAN. CURRENTLY THERE ARE THREE ONGOING RESEARCH PROJECTS WITH ANOTHER LAUNCHING THIS YEAR. IN 2015, WE BEGAN A RESEARCH PROJECT EVALUATING THE EFFECTIVENESS OF SAFE DRINKING WATER IN THE TREATMENT OF SEVERE ACUTE UNDERNUTRITION. THE STUDY WILL BE ONGOING THROUGH 2016 WITH FINDINGS SCHEDULED TO BE REPORTED IN 2017. OUR TEAMS HAVE ALSO RESPONDED TO A NUMBER OF EMERGENCIES IN THE PAST YEAR. HEAVY RAINS IN SINDH RESULTED IN STANDING WATER AND INUNDATION IN BADIN DISTRICT. WE IMPLEMENTED CASH-FOR-WORK PROGRAMS, RESTORED WATER FACILITIES, AND DISTRIBUTED HYGIENE KITS. WE ALSO RESPONDED TO THE OCTOBER 2015 EARTHQUAKE IN KHYBER PAKHTUNKHWA THROUGH NON-FOOD ITEM AND HYGIENE KIT

NIGERIA:
NIGERIA, PARADOXICALLY, IS THE LARGEST ECONOMY IN AFRICA - BUT IT HAS ONE OF THE HIGHEST NUMBERS OF UNDERNOURISHED CHILDREN IN THE WORLD. SINCE 2012, THE COUNTRY HAS FACED DEVASTATING INSECURITY IN THE NORTHEAST DUE TO BOKO HARAM VIOLENCE. DISPLACING 2.2 MILLION PEOPLE AND DIRECTLY AFFECTING MORE THAN 14.8 MILLION PEOPLE, THIS CRISIS WAS EXACERBATED BY HIGH UNDERNUTRITION RATES, POOR WATER QUALITY AND ACCESS, AND POOR SANITATION INFRASTRUCTURE. OPERATIONAL IN NIGERIA SINCE 2010, AAH-USA HAS PLAYED A LEADING ROLE IN STRENGTHENING NUTRITION SECURITY IN THE NATION'S NORTH OVER THE PAST FIVE YEARS. IN 2015, WE SIGNIFICANTLY SCALED UP ACTIVITIES IN ORDER TO MEET THE RISING NEEDS IN THE NORTHEAST. WE USED MULTI-SECTORAL APPROACHES TO ADDRESS

AFTER DECADES OF CONFLICT BETWEEN ARMED GROUPS FROM NEIGHBORING COUNTRIES, REGIONAL MILITIAS, ETHNIC GROUPS, AND GOVERNMENT FORCES, THE DEMOCRATIC REPUBLIC OF CONGO FACES ONE OF THE MOST COMPLEX CRISES IN THE WORLD. 729,000 PEOPLE FACED NEW DISPLACEMENT IN 2015. THESE ADDITIONS BRING THE TOTAL NUMBER OF DISPLACED IN THE NATION TO 1.6 MILLION. - EMPLOYEES ARE ANNUALLY ASKED TO ANNUALLY DISCLOSE ANY POSSIBLE CONFLICT OF INTEREST. IF A CONFLICT OCCURS, THE EXECUTIVE DIRECTOR REVIEWS THE ISSUE AND APPROPRIATE CORRECTIVE AND DISCIPLINARY ACTION IS TAKEN, WHERE APPROPRIATE.
