UNDERNUTRITION AND THE DISPLACEMENT OF POPULATIONS DUE TO CONFLICT ARE TWO OF THE MOST SIGNIFICANT HUMANITARIAN CHALLENGES THAT ACTION AGAINST HUNGER IS ADDRESSING IN PAKISTAN.
